A = the % of alcohol in wine to be fortified (i.e., that is produced by fermentation) B = the % of alcohol in the fortifying material. To demonstrate, assume 1000 gal (V) of wine is to be fortified to a desired 20%(C). The alcohol in the wine is 6.0% (A) and the percentage of the fortifying material is 84% (B). Therefore,
